**DESIGNATING THE CITIES OF CALAPAN (ORIENTAL MINDORO) and
PUERTO PRINCESA (PALAWAN) AND THE MUNICIPALITIES OF BOAC
(MARINDUQUE), ROMBLON (ROMBLON), AND SAN JOSE (OCCIDENTAL
MINDORO) AS ADDITIONAL TESTING CENTERS FOR THE SEPTEMBER 2022
LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS**

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and **to determine and fix the places and dates of examinations;**

WHEREAS, pursuant to Resolution No. 1439 (s. 2021), the Licensure Examination for Professional Teachers (LEPT) is scheduled on September 25, 2022 to be held in different cities and municipalities nationwide;

WHEREAS, the Commission received a communication from PRC Regional Office IV-B endorsing the inclusion of the provinces of Marinduque, Occidental Mindoro, Oriental Mindoro, Palawan, and Romblon as additional testing centers for the September 2022 LEPT. The Regional Office assured the availability of the budgetary requirements, supplies, and manning complement to support the conduct of the LEPT in these localities;

WHEREAS, the Professional Regulatory Board for Professional Teachers has no objection to the proposed additional testing sites as such will enable the examinees therein to take the September 2022 LEPT without unnecessary distant travel and additional expenses;

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate the cities of **CALAPAN (ORIENTAL MINDORO)** and **PUERTO PRINCESA (PALAWAN)**, and the municipalities of **BOAC (MARINDUQUE)**, **ROMBLON (ROMBLON)**, and **SAN JOSE (OCCIDENTAL MINDORO)** as additional testing centers for the September 2022 LEPT.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
