 - g. One (1) piece Long Transparent (non-colored) Plastic Envelope (for keeping your valuables and other allowed items)

 - a. Books, notes, review materials, and other materials containing coded data/information/formula.
 - b. PROGRAMMABLE CALCULATORS
 - c. CELLULAR PHONES, SMART WATCH, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH and other electronic gadgets/devices which may be used for communication purposes.
