IMPORTANT:

1. Check or verify your school/building assignments at the PRC official website (www.prc.gov.ph) or through the Notices/Announcements to be posted at the PRC premises two (2) to three (3) working days before the date of examination.
2. Report to the school/building assignment before 6:30 a.m. on the first (1st) day of the examination to verify your room and seat number. Be punctual. Late examinees will not be allowed.
3. Examinees are required to wear the following attire every examination day:
 1. Male Examinees - White polo shirt with collar (without any seal, logo or mark)
Decent pants or slacks
 2. Female Examinees - White blouse or shirt with collar (without any seal, logo or mark)
Decent skirt or slacks

4. Bring the following on examination day:
 - a. Notice of Admission
 - b. Official Receipt
 - c. One (1) piece metered-stamped window mailing envelope
 - d. Two (2) or more pencils (No. 2)
 - e. Ballpens with **BLACK ink only**
 - f. one (1) piece long brown envelope
 - g. one (1) piece long transparent/plastic envelope (for keeping your valuables and allowed items)
 - h. **One (1) clear and clean copy of 2 x 2** colored picture (preferably in white background) with name tag, and the complete address and school written at back of the picture. Put picture in a letter envelope with your name legibly written outside.

5. The following are **PROHIBITED** inside the examination premises/rooms.
 - a. Books, notes, review materials, and other printed materials containing coded data/information/formula
 - b. PROGRAMMABLE CALCULATORS
 - c. **SMART WATCHES, CELLULAR PHONES, EAR PLUGS, BLUETOOTH, TRANSMITTERS, PORTABLE COMPUTERS** and other electronic gadgets/devices which may be used for communication purposes.
 - b. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc.)
 - c. Other examination aides not stated on this program.

6. Use of Perry's Chemical Engineers' Handbook (2007 and 2008 editions) and updated Periodic Table in separate shall be allowed **ONLY in "Physical and Chemical Principles" and in "Chemical Engineering Principles"**
 - a. Handbook must be in its original printed form. Photocopy or xerox copy is not allowed.
 - b. Handbook must not have any handwritten formula, sample problem, notation or any such kind of writing or added information.
 - c. Insertion of photocopied pages, printed sheets or any other form of written materials is strictly prohibited.
 - d. Only bookmarks, tabs, underlines and highlights are allowed.
 - e. **Any loose sheet shall not be permitted.**

The proctors/watchers reserve the right to confiscate and/or refuse the use of Handbook found questionable or in violation of the above restrictions. Any willful attempt to use the Handbook as a means to cheat shall be dealt with accordingly and shall be a ground for disqualification from taking the licensure examination.

7. In the "General Engineering, Ethics and Contracts" subject (on Day 3, May 25, 2018), the use of Handbook and Periodic Table is strictly not allowed.
8. Read carefully and follow the instructions on your Notice of Admission and Examinees Kit.

NOTE: PRC WILL NOT BE ANSWERABLE FOR PROHIBITED ITEMS THAT WILL BE LOST.
