1. Bring your NOTICE OF ADMISSION when you verify your school/building assignment. Visit your school/building assignment prior to the day of the examination.
2. Report to the school/building assignment before 6:30 a.m. on the first day of examination to verify your room and seat number. Be punctual, late examinees will not be admitted. Examination Fee of ABSENT examinees will be forfeited.
3. Examinees are required to wear the following attire every examination day:
 - Male** : plain white polo or shirt with collar (without any seal, logo or mark)
decent slacks or pants
 - Female** : plain white blouse or shirt with collar (without any seal, logo or mark)
decent skirt or pants
