2. Report to the school/building assignment before 6:30 a.m. on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
3. Examinees are required to wear the following attire every examination day:

Female Examinees – Plain white blouse or shirt with collar (without any seal, logo mark)
decent pants or slacks or skirts

 - d. Two (2) or more pencils (No. 2)
 - e. Ballpens with **Black ink only**
 - f. One (1) piece long brown envelope

 - h. Non-programmable calculator (refer to list on the Examinees Guide).
