3. Examinees are required to wear the following attire every examination day:
Male Examinees – Plain white polo shirts with collar (without any seal, logo or mark)
decent pants or slacks
Female Examinees – Plain white blouse or shirt with collar (without any seal, logo mark)
decent pants or slacks or skirts
4. Bring the following on examination day:
 - a. Notice of Admission
 - b. Official Receipt
 - c. One (1) piece metered-stamped window mailing envelope
 - d. Two (2) or more pencils (No. 2)
 - e. Ballpens with **Black ink only**
 - f. One (1) piece long brown envelope
 - g. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items).
 - h. Non-programmable calculator (refer to list on the Examinees Guide).

5. The following are **PROHIBITED** inside the examination premises/rooms:
- Books, notes, review materials, and other printed materials containing coded data/information/formula
 - PROGRAMMABLE CALCULATORS
 - CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, SMART WATCHES, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED FOR COMMUNICATION PURPOSES;**
 - Bags of any kind (ladies bag, shoulder bags, attache case, backpacks, etc.)
 - Other examination aides not stated on this program.
