1. The **NOTICE OF ADMISSION** will be issued at the POLO/testing centers.
2. Please bring original documents with you for final evaluation and 4 pieces passport size pictures with nametag.
3. Bring the following on examination days:
  - a. Two or more pencils (No. 1 or 2)
  - b. Ballpens with **BLACK ink only**
  - c. One piece long brown envelope
  - d. One piece long transparent/plastic envelope
  - e. Non-programmable calculator

4. The following are **STRICTLY PROHIBITED** inside the examination premises/rooms:
  - a. Books, notes, review materials, and other printed materials containing coded data/information/formula (except Rules VII & VIII of the 2004 Revised IRR of P.D. No. 1096/1977 NBCP as qualified below)
  - b. PROGRAMMABLE CALCULATORS
  - c. CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, and other electronic gadgets
  - d. Bags of any kind (place your documents inside the transparent/plastic envelope)
  - e. Other examination aides not stated on this program.
5. Read carefully and follow instructions on your **Notice of Admission**.

**SPECIAL INSTRUCTIONS:**

1. On the second day (September 15, 2016), every candidate is required to bring to the examination room the following:
  - a. architect scales (English and Metric Scales)
  - b. 30 x 60 and 45 degree triangles
  - c. protractors
  - d. non-programmable calculators
  - e. pencils, drawing pens, erasers, graphed papers and other tools for sketching purposes
  - f. copy of Rules VII and VIII of the 2004 Revised IRR of P.D. No. 1096 "1977 National Building Code of the Philippines (NBCP)" which may be downloaded for free from the Latest Publication Section of the PRBoA Website ([www.architectureboard.ph](http://www.architectureboard.ph)).
2. Candidates will not be allowed to leave the examination rooms, borrow anything or communicate with one another on any subject matter. Every candidate is required to bring his/her lunch and/or supper (placed inside transparent/plastic bags) with him/her during the examination. No food of any kind carried by any person intended for any candidate during the progress of the examination shall be entertained by room watchers or received by any candidate.
